

Trade Compliance Notice and Certification

The Yacht Group is committed to fully complying with all applicable laws and regulations governing international trade, including the International Traffic in Arms Regulations (ITAR), Export Administration Regulations (EAR), and the economic and trade sanctions administered by the U.S. Department of Treasury Office of Foreign Assets Control (OFAC).

This document is to serve as a reminder that as a distributor of The Yacht Group products, you receive our products in accordance with our standard Terms and Conditions, which require compliance with such laws and requirements. Failure to comply can result in fines and/or penalties, imprisonment, and loss of export privileges.

The Yacht Group products and technical information are not to be exported, re-exported, trans-shipped, or otherwise transferred to any embargoed or prohibited country, including a resident or national thereof. Currently countries subject to U.S. embargoes are: Cuba, Iran, North Korea, Sudan, Syria, and the Crimea region. This list is subject to change, and it is your obligation to verify the current embargoes and restrictions before the transfer of The Yacht Group product.

The Yacht Group products and technical information are not to be exported, re-exported, trans-shipped, or otherwise transferred to any Denied or Restricted parties. This includes, but is not limited to any person or entity on the U.S. Department of Treasury List of Specially Designated Nationals and Blocked Persons and the U.S. Department of Commerce Denied Parties or Entity List.

The Yacht Group products and technical information are not to be exported, re-exported, trans-shipped, or otherwise transferred to any party if the goods are to be used or suspected to be used for any purpose connected with chemical, biological or nuclear weapons, or missiles capable of delivering such weapons, nor will the goods be used for any missile program or to enhance any missile technology.

Additional export restrictions are dependent on the classification of a product. It is your company's obligation to ensure you have the correct classifications of the products you purchase from The Yacht Group. These restrictions can include, but

are not limited to Russia, Venezuela, and China Military End Use restrictions and Russian Industry Sector Sanctions.
